## **TOWN OF LAKE VIEW CHRISTMAS PARADE** **RULES FOR PARTICIPANTS**

**HANDOUTS:** NO PARTICIPANT OF ANY UNIT IS ALLOWED TO PASS OUT LITERATURE OR THROW OUT OR HAND OUT CANDY OR OTHER EDIBLES. THIS IS STRICTLY PROHIBITED FOR SAFETY REASONS.

**CHILDREN:** Children under five (5) years of age may not walk or participate in a marching unit. Children must be at least three (3) years of age to ride on floats or other units and must have adequate supervision.

**MUSIC:** All units which play or broadcast music need to select music that is family friendly, in keeping with the holiday spirit and free from explicit or profane lyrics.

**SIGNS:** Each unit should use signs or banners to identify its sponsor and/or organization to the viewing audience. Banners and signs should be neat and easily legible from a distance. Basic, simple signs show the best.

**DRESS FOR PARTICIPANTS:** All individuals in the parade should dress appropriately for family atmosphere and with consideration of the weather.

**SMOKING:** Smoking is not allowed during the parade procession by parade participants.

**GUIDELINES FOR PARTICIPANTS:** All entries should be decorated for the holiday season and in a manner that is safe for all participants and spectators. An individual vehicle is not eligible to participate unless it is unique such as a recognized class or antique. All other units are required to have holiday decorations; otherwise, vehicles are only to pull floats. All riders should be part of the entry presentation and required to sit in the seats of the vehicle. Riders cannot ride on the back of the rear seat, sides or hood of the vehicle. All floats are to be built on a trailer or flat bed with at least two wheels pulled by a separate vehicle. Floats are to be decorated to reflect the holiday season. Pull vehicles should be an appropriate size. If you are driving a motorcycle, quad, dirt bike or any other ATV vehicle there will be NO doughnuts, wheelies or burn-outs allowed. Horses, for safety reasons, will be part of an organized equestrian unit with experienced riders and well-trained horses. All winners and representatives of beauty pageants must ride on floats or in automobiles.

**CONSUMPTION OF ALCOHOLIC BEVERAGES BEFORE OR DURING THE PARADE IS STRICTLY PROHIBITED. ANYONE SUSPECTED OF SUCH WILL BE DISMISSED FROM THE PARADE.**

NOTE: THERE WILL BE AN ON-SITE INSPECTION PRIOR TO THE PARADE TO DETERMINE THAT EACH ENTRY AND ITS PARTICIPANTS MEET THE CRITERIA SET FORTH IN THESE POLICIES, RULES AND GUIDELINES. ANY ENTRY NOT IN COMPLIANCE WILL BE REMOVED FROM THE LINE-UP. THESE GUIDELINES ARE TO ENSURE THE SAFETY OF THE PARADE ENTRIES, PARTICIPANTS AND THE VIEWING PARTICIPANTS. YOUR COOPERATION ENSURES THAT THE PARADE WILL BE A SAFE AND ENJOYABLE EVENT FOR ALL.
